From the President

WHEREAS:

1. Multnomah County Commissioners Naito and Rojo de Steffey have, on February 24, 2006, introduced a resolution calling for the county "to acquire a site as the first step towards constructing a new facility for the Fourth Judicial

District Circuit Court in, or in proximity to, downtown Portland's Government Center area by December 31, 2006"; and

2. The Commission's resolution further calls for development of a preliminary plan for such site acquisition within 60-days; and

3. The proposed resolution further observes that ORS 203.135 grants to the county "the power of eminent domain . . . to acquire any right or interest in real property for ... public building or public institution purposes"; and

THEREFORE, the board of directors of the Multnomah Bar Association **RESOLVES:**

- 1. To support the adoption of the resolution by the full County Commission at its March 23rd meeting; and
- 2. To authorize the president of the board of directors or his designee to attend the March 23rd meeting of the Commission to present testimony in support of the above-referenced resolution; and
- To support the use of the county's power of eminent domain to 3. acquire a site for a new courthouse in, or in proximity to, Portland's Government Center, should the exercise of such power be necessary to the acquisition of such site;

By the time this issue of the Multnomah Lawyer is delivered, the Multnomah County Commissioners hopefully will have acted on the proposed resolution. The MBA Board is united in the sincere hope that the commission's action is positive. The identification of a site for a new downtown courthouse is an important first step towards the ultimate goal of a new facility. It is my intent to appear in support of the proposed resolution at the commission's hearing on March 23. I will offer the board's resolution into the record.


Resolutions by the MBA Board are rare. In my five years on the board, I can recall only two other formal actions of this kind. The board closely reviewed the issue before acting. The prior resolutions of the commission on the courthouse issue, as well as the two most recent architectural and blue ribbon studies, were assembled and distributed to the board. The

Speaking for myself, the importance of keeping the courthouse downtown is both symbolic and practical. It is symbolically important for the courthouse to occupy a central location. County government, and particularly its hall of justice, would be diminished by its absence from, quite literally, the center of things. I am reminded of the relocation of the State Office Building to NE Oregon Street. The move did more than just change the location of some offices. It shifted the center of gravity in state government still further south. Statewide elected officials, with the exception of the Commissioner of Labor and Industries, don't spend much time in the Portland offices anymore. I think all of us all feel more removed from state government as a result.

The practical reason is economic: the relocation of the courthouse would threaten the prosperity of the downtown core. How many attorneys would follow the courthouse? Certainly not all; probably not most. But an indeterminate number would. And so necessarily would hordes of jurors and others with business at the courthouse. How many retail and eating establishments would feel the pinch of such an outmigration? How much commercial space would eventually empty and go begging for lessees? Someone undoubtedly has a better guesstimate than I do about the financial impact of relocating the courthouse, but my gut tells me it would be substantial, enough perhaps to hollow out the dynamic growth of downtown to the north and south.

These are reasons that may justify the condemnation of private property. It is regrettable that the county did not acquire the Two Main Place surface lot years ago, when the cost was substantially lower and there was a willing seller. But spilt milk won't build us a new courthouse: we need to move forward and, as Commissioners Naito and Rojo de Steffey propose, we need to do so now.

Please join me in supporting the commission's efforts to site a courthouse on Government Square.

resolution itself was the product of much revision.

The board carefully considered the advisability of invoking the power of eminent domain. The board ultimately and unanimously endorsed such action if necessary to keep the courthouse downtown "in, or in proximity to, downtown Portland's Government Center." That position was not taken lightly or easily. Yet all of us feel there are good reasons for keeping that option open.





Ethics Focus

Insurance Defense: Who's In Charge?

In recent years, insurers have increasingly relied on case management guidelines to control litigation costs. Although guidelines vary, they often direct prior approval of major activities like depositions and retaining experts and require detailed status reports and case plans. The advent of guidelines has, in turn, sparked a debate over the extent to which insurance defense counsel can ethically comply with them and whether the required reports fall within the attorney-client privilege. In this column we'll look at three related questions: (1) who is the client in Oregon insurance defense? (2) must an insurance defense counsel follow case management guidelines? and (3) are reports to insurers protected by the attorneyclient privilege?

Who Is the Client?

States vary in their treatment of whether an insurance defense counsel is considered to represent only the insured or both the insured and the insurer. In Oregon, an insurance defense counsel is generally considered under OSB Formal Ethics Opinions 2005-77 and 2005-121 to have two clients - the insured as the "primary" client and the insurer as a "secondary" client (but a client nonetheless).

Although the "two client" approach is the "default" position in Oregon, it need not always be the case. For example, a corporate insured with a large self-insured retention might want to make certain that "its" law firm remains available to handle coverage questions unhindered by a conflict arising from the "two client" model. In Oregon, the existence of an attorneyclient relationship is governed largely by the Oregon Supreme Court's decision in In re Weidner, 310 Or 757, 770, 801 P2d 828 (1990). In Weidner, the Supreme Court outlined a two-part test for determining whether an attorneyclient relationship exists: (1) the client must subjectively believe that such a relationship exists; and (2) that subjective belief must be objectively reasonable under the circumstances. Although there is no case law directly on point in Oregon in the insurance defense context, it should follow from Weidner that a law firm and an insurer could agree that the insurer will not be considered the law firm's client. In fact, the ABA took this view in a formal ethics opinion - 96-403 (1996) - concluding that the law firm and the insurer could expressly agree to limit the "client" to the insured only.



apply with equal measure to the "one client" and "two client" scenarios.

Both the OSB and the ABA have addressed insurance case management guidelines in ethics opinions that reach similar conclusions: OSB Formal Ethics Opinion 2005-166 and ABA Formal Ethics Opinion 01-421 (2001).

The OSB took a twofold approach in 2005-166. First, it concluded that insurance defense counsel could acknowledge receipt of the guidelines without necessarily agreeing to follow them. Second, the OSB stressed that insurance defense counsel would need to carefully and continually evaluate the guidelines as a case progresses. In reaching these conclusions, the OSB relied primarily on RPC 1.8(f), which directs that a lawyer's judgment on a client's behalf should not be swayed when another person is paying the bill, and RPC 1.1, which requires competent representation. 2005-166 contemplates that in most instances an insurance defense counsel will be able to comply with both case management guidelines and professional standards. But it concludes on a cautionary note: "If Lawyer cannot ethically comply with any particular aspect of the Guidelines, Lawyer must obtain a modification of the Guidelines from Insurer, or decline or withdraw from the representation."

The Attorney-Client Privilege.

Regardless of whether an insurer is the lawyer's "client" or not, reports, litigation plans and other correspondence concerning an insured's case are generally protected by the attorney-client privilege. Under the "two client" approach, OSB Formal Ethics Opinion 2005-157 puts such reports squarely within the privilege because the insurer is a co-client. Even in a "one client" scenario, however, the privilege applies through the "common interest doctrine," which was recognized in Oregon by Interstate Production Cr. v. Fireman's Fund Ins., 128 FRD 273, 280 (D Or 1989), and holds that disclosure of privileged information to a third party with a common or closely aligned interest is not a waiver.

Federal Court Filing Fees Increase April 9

Pursuant to the Deficit Reduction Act of 2005, passed by both House and Senate and signed by the President on February 8, 2006, the following fee increases become effective April 9:

- Court of Appeals filing fee increases from \$250 to \$450 District Court - civil action filing
- fee increases from \$250 to \$350 Bankruptcy Court filing fees
- Chapter 7 increases from \$220 to \$245, total due at filing \$299* Chapter 13 increases from \$150 to \$235, total due at filing \$274*
- Chapter 11 this fee remains unchanged at the moment due to a possible drafting error on the bill.

*The bankruptcy fee increases affect only the statutory chapter filing fees; all other fees collected at filing, such as the \$39 miscellaneous fee in all chapters and the \$15 case trustee fee in chapter 7 cases, remain unchanged.





Family law - child custody and parenting time evaluations

Because of the limited resources available from the Department of Family Services, Chief Family Law Judge Elizabeth Welch has implemented a new General Order restricting circumstances in which the Department of Family Services will conduct child custody and parenting time evaluations.

Effective immediately, the Department of Family Services will not perform child custody and parenting time evaluations in the following circumstances:

- Contempt or parenting time enforcement cases.
- Cases in which the current matter has been pending for more than six months.
- Cases in which the children are all over 15.

- Cases in which there has been a professional evaluation within the past two years, except to obtain an update. Updates will only be ordered where there has been a substantial change of circumstances since the completion of the last evaluation.
- Pending Juvenile Dependency cases.
- Cases in which the only matter pending is a Family Abuse Restraining Order Act (FAPA) restraining order.
- Cases of Probate Guardianship.
- Cases in which a parent is in prison.

The new General Order also provides that in cases where there has been a substantial break in the parent-child relationship, a history of abuse, or a significant criminal history, the first step would be supervised visits, not an evaluation.

Requests for evaluations by the Department of Family Services are to be scheduled for any Friday morning at 8:20 am. No stipulations for such studies will be allowed.

Order intended to enforce Multnomah County Circuit Court Supplementary Local Rule 12.015, which requires that before parents have a court hearing regarding child custody or parenting time, they participate in mediation.

Effective immediately, no pendente lite hearing regarding child custody or parenting time will be set unless the parties have obtained and complied with an order for mediation, unless the requirement for such an order has been waived by the court pursuant to SLR 12.015(4). Simply put, the parties must attend mediation subsequent to the filing of the petition, unless the court waives the requirement.

When the parties or their lawyers telephone the court to report ready for trial in cases in which child custody or parenting time are issues, if mediation has not been completed, the case will not be assigned out for trial.

On cases in which a judge has retained the case, because that judge has previously heard disputed matters, that judge's judicial assistant will not set trial dates unless mediation has

As an example of Judge Larsen's patience, during his first six months in FED court, a *pro se* litigant took much longer in trial than the parties had estimated. Rather

Judge Larsen is no stranger to hard work. Before graduating with honors from the U of O, he worked as a warehouseman in a box factory, drove a delivery truck, demolished and framed houses, sold newspaper ads and cooked in restaurants. He then landed a job in the Oregon House of Representatives as a legislative assistant.

After the legislative session ended, Larsen entered the U of O School of Law in Eugene. In law school, he was particularly drawn to constitutional law and trial practice, inspired by Professors David Schuman (now on the Oregon Court of Appeals) and Wayne Westling.

After graduating from law school in 1990, Larsen worked for the Coos County Public Defender in North Bend. In his first year,he handled Multnomah County office of Metropolitan Public Defender Inc. A great deal of his enthusiasm for his criminal practice came from trial work. He enjoyed advocating for clients, investigating, researching and presenting their cases. He successfully litigated many constitutional issues for his indigent clients.

After many years as a public defender, Larsen moved to Rieke and Savage, where he practiced criminal law representing courtappointed and retained clients. It was during this time that a personal tragedy forced him to reevaluate his energy for his criminal defense practice. His cousin was kidnapped and murdered. Larsen agreed to be the victims' representative for the family. He says, "I did a lot of soul searching and came to realize



public defenders and prosecutors who are in the trenches everyday."

After six years as a criminal defense attorney, he decided to explore another area of trial work - this time as a civil plaintiff's lawyer with Swanson, Thomas and Coon. In his two years at STC, he won all three of his civil jury trials, securing damages for his injured clients.

The partners at STC reignited his passion for bicycling. He began riding his bicycle regularly, something he had not done since college and continues to this day. Every Monday and Thursday at noon, you will likely see Judge Larsen (sans robe) with his other "bicycle buddies" gathering at Pioneer Square for the MBA noontime bicycle ride. Currently, he is working to establish an education and safety diversion program for motorists, bicyclists Juage Christopher Larsen

and pedestrians who violate traffic laws. The program would enable a first-time violator to obtain a dismissal of the charge or a fine reduction in exchange for successful completion of a "share the road" safety and legal education class at a local hospital.

Outside of his work, Judge Larsen and his family enjoy spending time in the outdoors. He and his wife, attorney Kelly Skye, are the proud parents of two daughters. A native Oregonian, he spends most of his free time snow skiing, backpacking, fly-fishing and running rivers in his grandfather's antique McKenzie River drift boat. Larsen comes from third-generation river guides, all graduates of the U of O. He notes, "Kelly and I are drawn to the outdoors and want to instill in our kids respect and admiration for our environment."



Clackamas Bar Report

Kristen David, President of the Clackamas County Bar Association, attended the meeting as a part of the committee's commitment to liaison to neighboring bar associations. She reported on the appointment of Steven Maurer as Presiding Judge, and on his priority for getting the Oregon Judicial Conference's Standards of Timely Disposition taken seriously in Clackamas County. She also discussed the need for more judges; Clackamas County received one new position in 2005 to be effective in January 2007, but remains underserved even with that addition. And, like Multnomah County, she said, the court facilities are inadequate to support the current needs of the court in Clackamas County.

Courthouse Report

Doug Bray told the committee that the presiding judge had reported to the Multnomah County bench, at Judge David Gernant's request while away on vacation, that he plans to retire on April 1, 2006. Judge Gernant's present term of office expires in January; the position is on the ballot for the next general election. Discussion ensued about providing notice to members of the pending vacancy so that individuals who wished to file for election for this position would have the opportunity to do so. A motion to recommend that the MBA Board circulate information regarding the vacancy passed.

by Commissioner Lisa Naito. The resolution will be on the March 23 agenda of the Board of County Commissioners for approval. The resolution directs the county to begin a site acquisition process for a new courthouse in downtown Portland. MBA President Kelly Hagan and members Ed Harnden, Charles Williamson and Carlton Hodges, along with Presiding Judge Dale Koch and Chief Criminal Judge Julie Frantz, have been asked to speak in support of the resolution.

Subcommittee Reports Jury Verdict Subcommittee

Another format for potential report was presented and discussed. This format displayed cases with verdicts and money awards to judgment creditors. The committee was pleased with this presentation of the information and requested only that another column be added to indicate whether the judgment creditor was a plaintiff or defendant. The committee discussed methods of making the report available and recommended that information be posted on the MBA Web site.

OJIN Subcommittee

The office of the State Court Administrator is considering adding the capacity for one additional email address per lawyer for notifications of court hearings by email. This had been recommended by the subcommittee in its review of the OJIN Email Notice System.

CourtCare

WinterSmash was a success, raising approximately \$14,500 and attracting 180 folks, including 40 or more children. April 24 through May 5 is the CourtCare Fundraising Campaign.

Emergency Safety Planning Committee

Chair Hagan reported that she is, by appointment of the MBA President, serving on this committee, chaired by Judge Tennyson. The committee discussed challenges that would arise should the courthouse be disabled, as Marion County's has been. That facility, damaged by a fire on November 13, 2005, remains out of commission months later due to asbestos and smoke spread throughout the entire building.

The fall Judicial Brown Bag drew 50 persons to Judge Wilson's Courtroom. Details of the spring session, organized by Judge Christopher Marshall, will be announced soon.



CourtCare's 3rd Annual Fundraising Campaign April 24 – May 5

When parents who cannot afford childcare go to court, they must bring their young children into the courtroom or leave them waiting in the hallways, exposing them to disturbing events and disrupting courthouse proceedings.

The Multnomah CourtCare program provides free, drop-in childcare for those children in the Multnomah County Courthouse. The program is operated by Volunteers of America Oregon. Space and budget limitations keep the program from accommodating all who need care, but it has served more than 4,400 children since opening in December 2001.

CourtCare receives some public funding, but without the financial support of the legal community, its doors would close.

In addition to seeking contributions from individuals, the CourtCare Campaign stages a competition among law firms and other organizations, including the DA's Office, Metro Public Defender and Multnomah County judges and courthouse staff. Last year's "Proudest Pride" award went to Davis Wright Tremaine for largest firm contribution, and Williams Love O'Leary, Craine & Powers won the "Loftiest Leap" award for highest per capita contribution.
