Multnomah County Judges Trial Practices Update

This year's Trial Practices Update will feature presentations by **Judges Maureen McKnight**, **Stephen K. Bushong and Edward J. Jones**. The seminar will focus on evidentiary issues that Multnomah County judges frequently see novice and seasoned trial lawyers struggle with, and will include particular emphasis on the following:

- Admitting trial exhibits into evidence including laying a proper foundation and best practices tips;
- Use of prior statements at trial, including depositions and other out of court statements;
- Evidence regarding reputation, character, and prior bad acts; and
- Practical considerations in determining whether or not a prior statement is hearsay.

The panel will also identify, and discuss approaches for avoiding significant trial practice mistakes that Multnomah County judges frequently encounter.
