For Law Firms and Other Entities that Fall Within
the Definition of a Business Associate

HIPAA Omnibus Rule compliance deadline is September 23, 2013. If
you or any of your clients are business associates, have you (they)
done everything to be in compliance? This presentation will cover the
definition of a business associate and when a law firm may fall within
that definition. Provisions of the Omnibus Rule that affect business
associates will be discussed along with a checklist that business
associates can use to confirm their compliance with the Omnibus Rule.
The presentation will also touch upon business associate agreements
and provisions important for that document from the business
